**Pan Card Copy Compulsory :** your personal data filled in the membership form (Name & Sign.) should match with your pan card.

**Partnership Concern:** if membership is for a partnership concern Partnership Deed is required on Rs. 750/- stamp paper duly notarized (1 card Fee Rs. 200/- per partner & maximum for 3 partners shall be issued.)

**Ltd. & Pvt. Ltd. Co. :** If membership is a company Pvt. Ltd/ Limited/Association a copy of Memorandum of Articles of Company/ Association is required.

**Title registration fee:** Rs. 350/- per Title (i.e for Film Regional Film, Music Album, T.V. Serial, T.V. News, DVD, Video Film & Dub Film). The fees for TV Show/ Event Show is Rs.1200/- per Title.

The title registered also has to be renewed by paying Rs. 500/- for 1<sup>st</sup> renewal and Rs.600/- for 2<sup>nd</sup> renewal and Rs. 1600/- for thereafter renewal.

**Important Note:** The Membership registered shall expire after one year and the same has to be renewed every year by paying Rs. 758/- as yearly subscription by Cash/D. Draft towards the same.
